**NEW BUSINESS:** 

1. Wes Christmas re: Main Street Update

Mr. Severns stated that if it ever quits raining they will continue to pave the road. He explained that they will continue on from 16th to Vincennes to work on the road in that area as the rain stops as well. He stated that the monument towers at 5th and 15th are almost completed and the planters are being placed next week. He explained that the trees are ready to go in once the rain stops and the new signs are starting to be placed along the road.

Mr. Nash stated that he noticed some waviness in the pavement and asked if anything was going to be done about that.

Mr. Severns stated that there has been quite a bit of work done to that and explained that they have wedged and leveled but there will be rise at the cross streets because of the side streets but he hasn't noticed any waviness.

Mr. Severns stated that he will bring it up to Mr. Christmas.

2. Vectren re: Cut permits for 221 E 5th St (11662334)- Street Cut, 2321 Park Ave (11629956)- Side walk Cut-Bore

Mr. Philpot stated that 2321 Park looks like a sidewalk bore to him and doesn't think they will be out in the street.

Mr. Thompson moved to approve, Ms. Cotner second, motion carries.

Craig Kleis requested a street cut permit at 341 Vincennes Street to tap existing water main to install fire protection sprinkler system. He explained that there will be a sidewalk cut on the building side to receive the bore.

**Mr.** Nash asked Police Chief Bailey how the Harvest Homecoming went and if there was any issues with the request from Wick's. **Police Chief Bailey** stated that they didn't have any significant problems.

Mr. Thompson stated that they did redirect traffic on Market coming out of the parking garage and they will talk

about it with them more next year to address the congestion.

Mr. Nash stated that some sidewalks were blocked and that needs to be addressed as well.
