Mr. Nash introduced R-17-01 and moved to approve, Mr. Phipps second, all voted in favor.

Mr. Duggins stated that they have 40 new jobs at entry wages of \$25,000.00 per year. He added that Hitachi is one of their strongest employers in the community and recommended approval.

Mr. Barksdale stated that there is a typo in the resolution in the fourth paragraph that repeats a phrase.

Mr. Aebersold asked about the time frame for the 40 new jobs.

Mr. Duggins stated that the resolution stipulates within the life of the abatement but Hitachi's past has been to immediately add employees.

Mr. Barksdale stated that they have to protect the established companies so for him this is a given.

COMMUNICATIONS – PUBLIC (NON-AGENDA ITEMS):

City Council January 5, 2017 William Haskins stated that he lives on Navajo Drive and he is concerned because every year there are always a few neighbors who do not rake their leaves. He explained that the resident at 511 Navajo Drive never rakes and waits until late January, February or March because they know their neighbors will do it for them He read a letter to the council that he intended to send to the resident and then read the letter that he actually sent to the resident in a Christmas card. He asked the council to fine the people that are not raking their leaves and to send out notices to educate the public about raking their leaves.

Mr. McLaughlin asked if the leaves are just in his yard or if they are getting in the street.

Mr. Haskins stated that they get into the gutter.

Mr. McLaughlin stated that he isn't sure what the ordinance says about forcing individuals to rake their leaves but that is something they could look into.

Mr. Blair asked if there is anything in the ordinance that addresses this issue.

Mr. McLaughlin stated that he doesn't think the ordinance addresses raking leaves but they can request some guidance from Mr. Brewer and the building department.

Mr. Haskins stated that he is a Veteran and goes to the VA Hospital and asked about the opportunity for a hospital in this community.

Dr. Knable stated that it is in a different district so it has to stay in Kentucky.
