### **CALL TO ORDER:**

Mr. Nash called the meeting to order at 10:00 a.m.

# **PLEDGE OF ALLEGIANCE:**

### **NEW BUSINESS:**

1. Gary Brinkworth re: St. Joseph Crossing Plat approval and signed

**Mr. Brinkworth** presented the St. Joseph plat and explained that Mr. Summers has the plans for the project and they are ready to go.

**Mr.** Nash stated that he was concerned about the lot sizes and asked Mr. Summers if he had any issues with them.

**Mr. Summers** stated that it fits the development standards that were approved by the Plan Commission.

**Mr. Brinkworth** stated that he doesn't know what the restrictions call for but he is thinking they will be up to 1,400 or 1,500 feet.

Mr. Nash asked Mr. Summers if he had any problems with that.

Mr. Summers replied no.

Mr. Nash asked how far along they are.

**Mr. Brinkworth** stated that the only thing left to do is pave.

Mrs. Cotner-Bailey asked if Fire Marshal Koehler reviewed it.

2. Ed Evans with JDH Contracting re: Boring permit on Main St. (W. 4<sup>th</sup> back of Lafayette)

**Brian Harris** stated that Mr. Evans was not able to attend the meeting. He presented plans for the board's review and explained that they need to get a boring permit on the north side of Main Street to install a 2" conduit.

Mr. Thompson asked if they were going to be under Main Street

**Mr. Harris** stated that they will be in the right-of-way.

- **Mr. Thompson** asked where the bore pit would be located.
- **Mr.** Harris explained that it will be really close to the pole on the sidewalk or grass.
- **Mr. Nash** asked what the purpose of this is.
- **Mr.** Chris Gee stated that they are installing the conduit unground so that they can install the fiber to serve the Gallagher Power Plant. .
- Mr. Thompson asked if there are any utilities that have to be pot holed.
- **Mr.** Harris stated that once they get the locates called they will pot hole all the utilities before they do any work and if they are required to pull any sidewalks out they will replace them.
- Mr. Thompson moved to approve, Mrs. Cotner-Bailey second, motion carries.
- 3. INAWC re: Street cut permits at 1341 Slate Run Road (main break) and 1260 Vincennes Street (main leak)
- Mr. Thompson moved to approve, Mrs. Cotner-Bailey second, motion carries.
- 4. Vectren re: Cut requests for 909 E. 15<sup>th</sup> St. (12936968) street cut, 1407 Adams Ave. (12893293) street cut x3, 2411 Jolissiant Ave. (12477269) street cut x2, 3221 Grantline Rd. (13080296) street cut
- **Mr. Harbison** stated the cut at 909 E. 15<sup>th</sup> appears to be in the alley and the one on Grantline is actually off Grantline on Pillsbury.
- Mr. Thompson moved to approve, Mrs. Cotner-Bailey second, motion carries.

**Tabitha Heid** stated that she has a POD on the street in front her home at 111 Rossmore Drive and apologized that she didn't know that she needed a permit from the board. She explained that they are in the process of getting their house ready to sell and it will probably be full within the next month but two months at the most.

- Mr. Nash asked if she room on her property.
- **Ms. Heid** explained that their driveway is on a slope and blacktopped and she was told by the company if they tried to install the POD there it would damage the blacktop.
- Mrs. Cotner-Bailey asked how long it has been on the street.
- Ms. Heid replied two weeks.
- Mr. Nash asked what size it is.
- Ms. Heid replied 10'X16'
- Mr. Thompson moved to approve the POD for one month, Mrs. Cotner-Bailey second, motion carries.

Antwone Jennings stated that a lot of people are passing away and he would like to make some sort of monument to honor them. He explained that he hasn't drawn anything up but would like to use the Division Street School as a model where they put names in the bricks of people who attended that school. He stated that he is before the board to find out what the policy is for this time of tribute. He stated that he is going to try to set up a meeting at the church to get some input from the community and he will come back with a plan.
