Mayor Gahan called the meeting to order at 9:15 a.m.

### **SEWER ADJUSTMENTS:**

**Mrs. Dickey** presented an adjustment request for Frank Allen in the amount of \$1,183.16 for a leak that occurred in the entire water line from the street to the house. She explained that the water went into the ground and the leak was repaired by Irrigation Plus. She added that consumption is now back to normal. Supporting documents attached.

Mr. Grimes moved to approve, Mr. Wilkinson second, all voted in favor.

## **FINANCIAL REPORT:**

**Mr. Wilkinson** reported that the revenue is right on the budget; they took in \$1,160,000.00 and spent \$1,060,000.00

## **OLD BUSINESS:**

### 1. Clark Dietz Update

Mr. Christmas, Basin 16 Division A - he reported there was some activity in the last couple of weeks taking care of punch list and other miscellaneous items. He stated that they regraded and seeded the entire area and prepped the remaining areas for paving, but he doesn't have a date yet on when they will pave. He explained that there is one flow control structure to be installed and it has been delivered and is on site. He added that they hope to start installation this week. Basin 14 – he reported that Dan Cristiani is close to having the site excavated so that they can start pipe installation and hope to start that at the end of this week or the beginning of next week. Daisy Lane Lift Station – he reported that they have made some tie-ins at some of the existing facilities and are getting ready to set the new structure for the lift station expansion. He added that even though the weather has slowed them down they still anticipate meeting the contractual completion date.

Mr. Summers stated that he has been discussing the potential for additional hours for Basin 14

and asked Mr. Christmas if he wanted to inform the board.

**Mr. Christmas** stated that Dan Cristiani has requested to work this Saturday to complete the excavation.

**Mr. Summers** stated that area is relatively isolated with one home/daycare in the area and his only concerned would be them starting too early. He recommended that if the board does approve this request that they start at 9:00 a.m.

**Mayor Gahan** said that if the board approves this request, he will get with Mike Hall to get that information out to the residents and businesses that will be affected.

**Mr.** Christmas stated that he has copied Mr. Hall on all of the correspondence and they will run any request like this through the proper channels.

Mr. Summers stated that he doesn't see this as an issue at all.

Mr. Grimes moved to give Mr. Summers the authority to advise time constraints that are in the contract as he sees fit, Mr. Wilkinson second, all voted in favor.

**Mr. Christmas** stated that he and Mr. Sartell attended the ACEC Awards earlier this week on behalf of the sewer utility and the City was acknowledge and recognized for the Basin 16 Project and received a merit award. He added that Mr. Sartell has the plaque that was presented to them.

**Mr. Wilkinson** stated that pioneering of that sort of thing for a small city is a big deal.
