THE SEWER BOARD MEETING OF THE CIVIL CITY OF NEW ALBANY, INDIANA, WAS HELD IN THE THIRD FLOOR ASSEMBLY ROOM OF THE CITY-COUNTY BUILDING ON THURSDAY, JULY 13, 2017 AT 9:15 A.M.

PRESENT: Ed Wilkinson, member, Nathan Grimes, member and Mayor Gahan, president.

ALSO PRESENT: April Dickey, Larry Summers, Rob Sartell, Linda Moeller and Vicki Glotzbach

CALL TO ORDER:

Mayor Gahan called the meeting to order at 9:15 a.m.

PLEDGE OF ALLEGIANCE:

APPROVAL OR CORRECTION OF THE FOLLOWING MINUTES:

Mr. Grimes moved to approve the June 22, 2017 Regular Meeting Minutes, Mr. Wilkinson second, all voted in favor.

BIDS/CONTRACTS:

1. Rob Sartell re: Brown Equipment quote for AQUATECH Combination Sewer Cleaner

Mr. Sartell presented a sales quote for a 2017 AQUATECH sewer cleaning machine and list price is \$364,000.00 but there will be a \$10,000.00 deduct on that because it is a demo model. He said that brings the cost down to \$354,000.00 and with trade off of the 2003 AQUATECH in the amount of \$37,500.00, the final cost is \$316,500.00. He stated that this will replace the 2007 AQUATECH that we currently have.

Mr. Grimes asked if it has been a good piece of equipment.

Mr. Sartell stated that all of the AQUATECHs have been very good performers.

Mr. Wilkinson asked if any new features have been added over the seven years.

Mr. Sartell stated that they offered a new feature which was more vacuum but we just didn't need it for those depths so he waived it off so it is pretty much the same thing as the 2013 and we bought that one for \$301,000.00 so it has gone up a little bit like everything else.

Mayor Gahan asked the model year of the one that's being replaced.

Mr. Sartell stated that it is the 2003 and we are trading it in.

Mayor Gahan asked if these are lasting about the right lifespan.

Mr. Sartell replied yes and stated that the one we are trading in has been used for 14 years so that is pretty good.

Mr. Wilkinson stated that when we handed that one off to storm water the last time, the value was \$40,000.00 so we've only lost \$3,000.00 and got another four years.

Mr. Grimes moved to approve, Mr. Wilkinson second, all voted in favor.

2. Rob Sartell re: Brown Equipment quote for AQUATECH Repair Estimate

Mr. Sartell presented a rehab quote for the existing 2007 AQUATECH which we will pass off to storm water and that should give them another 10 years of a fairly good piece of equipment. He stated that the mileage on these engines are low because they are not around a whole lot but the wear and tear is on the vacuum unit and the pressure part of it. He explained that to rehab the 2007 completely Brown Equipment has given a quote in the amount of \$23,487.00.

Mr. Grimes asked how long it will take.

Mr. Sartell replied probably about a month but he will nail it down for sure.

Mr. Wilkinson asked if the \$23,487.00 would come out of the line item in the budget for equipment repairs.

Mr. Sartell replied yes. He then stated that when they rehabbed the 2003, it was almost \$30,000.00 so we are in a little better shape on this one.

Mr. Wilkinson moved to approve, Mr. Grimes second, all voted in favor.

3. Rob Sartell re: JWC Environmental quote for New Albany WWTP Project

Mr. Sartell stated that out at basin 14 they have a piece of equipment that is known as a muffin monster and is pretty much a set of rotating teeth the eats up sticks, rocks, etc. and protects those \$180,000.00 pumps we have at the Basin 14 Lift Station which is a wet weather station. He said that it only runs when we have high flows but it pumps directly into the plant past the coarse bar screens so to protect the downstream equipment at the plant, we installed this in 2005. He stated that it has been 12 years since it has been in operation and now needs to be replaced due to normal wear and tear. He presented a picture of the muffin monster for the board to review and said that turnaround would probably be about a week and the quote is for \$34,710.00.

Mr. Grimes asked if that price is what has been paid in the past.

Mr. Sartell stated that we bought this in 2005 for \$50,000.00.

Mayor Gahan stated that it is a necessary piece of equipment.

Mr. Sartell agreed.

Mr. Grimes stated that we will get about 10-12 years out of it by doing this so the cost is actually going down for that piece of equipment.

Mr. Sartell stated that is correct and that a new one would cost about \$60,000.00-\$65,000.00.

Mayor Gahan stated that he would like to put this on the list of things to communicate to the folks in Chicago about what we are doing to make improvements.

Mr. Wilkinson moved to approve, Mr. Grimes second, all voted in favor.

Mr. Wilkinson reported that this month is a typical average month. He said that we are \$40,000.00 short as far as revenue coming in versus expenses and that's right where our July 1st estimate was that we were going to be needing in our increase. He also said that the July increase will be billed next month so we will begin the new rate. He added that we are running about 5% points below budget.

1. Wes Christmas re: Clark Dietz Update and Sewer Credits Update

Mr. Christmas handed out for reference/review, the 90% plans for the Basin 7 Project. He stated that he hopes to get comments and feedback and once they do they will incorporate those into the project and it will be ready to bid. He explained that they had some follow-up correspondence with the EPA requesting that they meet and the response they received back was that they are in the process of reviewing the submittal and anticipate getting something back to the city within a couple of weeks. He stated that until they get they get a response back the EPA thinks a meeting would be premature but once they do it seems as though they will be willing to sit down and talk.

Mayor Gahan asked Mr. Wilkinson and Mr. Grimes if they saw a copy of that email.

Mr. Wilkinson replied yes.

Mr. Grimes replied yes.

Mayor Gahan stated that he thought the first response seemed kind of promising and asked if there was anything in that letter that indicated that as well.

Mr. Christmas stated that they have had positive indications from the project manager but it seems as though when it goes through the upper management for review is where they run into some snares.

Mayor Gahan stated that it seems that it should be easy to move this forward especially with the steps that the city has taken.

Mr. Christmas stated that everyone on this end has done a lot and they don't think they are asking for more than what they should get.

Mayor Gahan asked Mr. Christmas to keep them posted.
