- MONDAY 10/5/2020 Seven Seas demoed and poured driveway approaches at Ellen Ct. Libs milled Plaza Drive, Hickory Grove, and Deerwood Dr. They also completed the patching on Hickory Grove. Patching was already complete on Deerwood Dr. and Plaza Dr. the previous week

## **COMMUNICATIONS – CITY OFFICIALS:**

1. Krisjans Streips re: New Albany Tree Board Tree Planting Project - Phase 2

**Mr. Streips** stated that he submitted the plans for phase 2 with their packets that included a list of which trees would be used and a map with indicators for both phase 1 & 2. He explained that they will not start phase 2 until phase 1 is done but the entire project should be complete by the end of the year.

Mrs. Cotner-Bailey moved to approve, Mr. Nash second, motion carries.

## 2. Larry Summers re: Slate Run Road Update

**Mr. Summers** explained that the contractor was supposed to begin installing the mailboxes last week but there was an issue with the shipment. He stated that he was notified that they are now on site and installation of the mailboxes and signage should happen today. He reported that they should see handrail and guard rail going up this week as well as finishing off punch list items.

**Mr.** Nash asked if they have done a walkthrough.

**Mr. Summers** explained that they gave them a preliminary punch list to give them a head start so they can get as much done before they do a final walkthrough.

**Mr. Applegate** asked Mr. Summers to look at the crosswalk entrance and exit at Mac's Hideaway when they are looking at signage for Slate Run because it ends abruptly and is a safety concern.

# 3. Chris Gardner re: 8th Street Culvert Update

**Mr. Gardner** reported that the culvert has been installed and AT&T is working out their solution for the utility conflict. He added that they hope to have the project completed within the next week and a half.

# 4. Chris Gardner re: Road closures for annual levy inspection.

**Mr. Gardner** explained that annually they are required to do trial inspections and operations on the levee system, particularly the moveable closures (flood gates). He stated that this year they have five gates scheduled and he needs approval for road closures and temporary detours for West 10<sup>th</sup> Street (November 5 at 8:00 a.m. – November 6 at 3:00 p.m.), Glenwood Park and Glennwood Court (November 10 from 9:00 a.m.-3:00 p.m.), Providence Way (November 12 from 9:00 a.m. – 3:00 p.m.), and 18<sup>th</sup> Street (November 13 from 9:00 a.m.-3:00 p.m.

Mr. Nash asked if they would notify the public.	
Mr. Gardner replied yes and added that they can also place advanced signage.	
Mrs. Cotner-Bailey moved to approve, Mr. Nash second, motion carries.
