

**THE SEWER BOARD MEETING OF THE CIVIL CITY OF NEW ALBANY, INDIANA, WAS HELD IN THE THIRD FLOOR ASSEMBLY ROOM OF THE CITY-COUNTY BUILDING ON THURSDAY, JANUARY 24, 2019 AT 9:15 A.M.**

**CALL TO ORDER:**

**Mayor Gahan called the meeting to order at 9:15 a.m.**

**PLEDGE OF ALLEGIANCE:**

**APPROVAL OR CORRECTION OF THE FOLLOWING MINUTES:**

**Mr. Grimes moved to approve the January 10, 2019 Regular Meeting Minutes, Mr. Wilkinson second, all voted in favor.**

**BIDS/CONTRACTS:**

**1. Rob Sartell re: Bids for Dump Truck**

**Mr. Sartell** explained that he would like to take this under advisement because of a few issues they would like to review before making a decision.

**NEW BUSINESS:**

**1. Don Thieneman re: The Villas Lift Station Transfer**

**Mr. Sartell** explained that Mr. Thieneman has a lift station at The Villas of Floyds Knobs that is past its one year demonstration period. He stated that Mr. Thieneman has installed the SCADA system and drawn up a warranty deed for the property so he would recommend that the board accept the lift station.

**Mr. Wilkinson** asked Mr. Sartell if he has gone through the check list and everything is in order.

**Mr. Sartell** replied yes.

**SEWER ADJUSTMENTS:**

**Mrs. Dickey** presented an adjustment request for Holiday Inn Express in the amount of \$6,988.32 for a leak that occurred in a pipe under the floor in the 1<sup>st</sup> floor corridor. She explained that the water came up through the floor and had to be manually removed and the leak was repaired by Dauenhauer Plumbing. Supporting documents are attached.

**1. Clark Dietz Update**

**Mr. Christmas, Basin 14** – He stated that they had a pre-construction meeting yesterday with Dan Cristinani with plans to issue a notice to proceed effective on or before February 4. He added that the schedule for that project includes substation completion within 120 days which would take them to early June. **Daisy Lane Lift Station Project** - He explained that at the last meeting they opened bids for this project and awarded it to Temple & Temple contingent upon review and submittal of several document. He state that all the required documents have been received and reviewed for proof of responsibility and he would like to formally award the project to Temple & Temple.
