

THE SEWER BOARD MEETING OF THE CIVIL CITY OF NEW ALBANY, INDIANA, WAS HELD IN ROOM 100 AT NEW ALBANY CITY HALL ON THURSDAY, JANUARY 27, 2022 AT 9:15 A.M.

PRESENT: Ed Wilkinson, member, Nathan Grimes, member and Mayor Gahan, president.

CALL TO ORDER:

Mayor Gahan called the meeting to order at 9:15 a.m.

SEWER ADJUSTMENTS:

Mrs. Dickey presented a leak adjustment request for Tyler Offutt in the amount of \$4,907.60 for a leak that occurred under his driveway. She explained that the water went into the yard and the leak was repaired by Greenwell Plumbing. She also explained that both members of the household were deployed overseas over the past year so this created a delay in both repairs and payment. She said that their consumption is now back to normal. Supporting documents are attached.

Mr. Grimes moved to approve, Mr. Wilkinson second, all voted in favor.

FINANCIAL REPORT:

Mr. Wilkinson reported that the year-end numbers were pretty good. He stated that the income was 98.9% of the budget and expenses were ~9.5% below budget, which means they ended the year with ~\$1.3M carryover. He reported that the two big items that are repetitious are the electric that keeps going up and the other is insurance but they both stayed inside the budget and have been properly identified and appropriated.

Basin #13 Lift Station
EZ Construction was awarded the low bid on May the 3rd. Waiting on equipment delivery.

Mr. Sartell stated that they did have to do a dig up this week in an alley between Market and Main streets and reported that the line was full of grease from a restaurant. He stated that they are going to have to get with that restaurant to have them up their cleaning schedule.

Mayor Gahan asked how the employees are holding up.

Mr. Sartell reported that they have had a few that have had to take off and follow protocol but it has been much more manageable this time around.

Mr. Wilkinson stated that the distillery has a pretreatment and they have announced that they are going to expand again, which is great news, but asked if they normally do monthly sampling with that pretreatment to keep track of what is going on.

Mr. Sartell stated that Indiana has issued a discharge permit so they have to report to the city what they discharge and what they are testing for. He explained that they do comparison samples on an annual basis and if they are out of compliance they have to renegotiate the permit and make changes.

Mr. Wilkinson stated that until they put in a distillation column they won't be splitting out chemicals because that is what kicks them out.

Mr. Sartell stated that they have a fairly advanced treatment plant so it is easy to monitor.
