

**THE SEWER BOARD MEETING OF THE CIVIL CITY OF NEW ALBANY,
INDIANA, WAS HELD IN THE THIRD FLOOR ASSEMBLY ROOM OF THE
CITY-COUNTY BUILDING ON THURSDAY, MAY 11, 2017 AT 9:15 A.M.**

PRESENT: Ed Wilkinson, member, Nathan Grimes, member and Mayor Gahan,
president.

CALL TO ORDER:

Mayor Gahan called the meeting to order at 9:15 a.m.

PLEDGE OF ALLEGIANCE:

APPROVAL OR CORRECTION OF THE FOLLOWING MINUTES:

**Mr. Wilkinson moved to approve the April 27, 2017 Regular Meeting Minutes, Mr.
Grimes second, all voted in favor.**

BIDS/CONTRACTS:

COMMUNICATIONS - PUBLIC:

Jerry Leonard, Executive Director, Habitat for Humanity, requested a waiver of the
sewer tap for a property at 1419 South Street which is the next build that they are going
to pull a permit on. He stated that this lot was donated to them through New Albany
Clean & Green and the sewer board was kind enough to help them with their last project.

Mr. Wilkinson stated that the board hasn't had a chance to look at this so they would like
to take it under advisement until the next meeting.

Mr. Leonard stated that they are trying to get the foundation work started but they need
to pay or get the tap fee waived before then can do that.

Mr. Gibson stated that the building department requires that before they will release the
permit but he can take care of that component and follow up with Mr. Leonard.

Mr. Sartell asked if there was ever a home on the site before.

Mr. Leonard stated that it has been vacant property for a long time but he does believe
so.

Mr. Sartell stated that they will go out and investigate to see if there is already a tap at
the location.

Mr. Gibson suggested that they let Mr. Sartell do that first and then eventually they
should set up a policy regarding tap fees for non-profit organizations.

SEWER ADJUSTMENTS:

FINANCIAL REPORT:

Mr. Wilkinson stated that revenue is down approximately \$80,000.00 this month but it will come back up next month. He explained that on the budget-to-actual page as they begin to build a negative, it is actually the money that comes out of the EPA projects, not negative operations. Operating expenses are under budget.

NEW BUSINESS:

OLD BUSINESS:

1. Wes Christmas re: Clark Dietz Update

Mr. Christmas stated the restoration work is moving forward on the Grant Line Lift Station and the final items should be wrapping up by the end of May. He explained that he has final plans for the Old Vincennes Lift Station and he will get them to Mr. Sartell for final comments.

Mr. Wilkinson asked if they will get most of that done this construction season.

Mr. Christmas replied yes.

UTILITY REPORT:

Mr. Sartell reported that on April 29th they had 4.3” of rain in 17 hours which resulted in 11 overflows but it was above the design limit so there wasn’t anything that they could do about it. He stated that on May 5th they had 3.1” of rain in 34 hours with 7 overflows.

Mr. Wilkinson asked Mr. Christmas if there has been any type of chart created that charts the level of rain and what the consequence of that will be.

Mr. Christmas stated that there are public documents that have a list of those.

Mr. Wilkinson asked if he could email it to the board.

Mr. Christmas replied yes.

Mayor Gahan stated that he didn’t know that information was available but it would be very helpful. He asked if they would be able to look at that information and know how the system should perform.

Mr. Christmas replied yes and stated that they can chart and determine if it is in excess of a 5 year event very quickly.

Mr. Wilkinson explained that the new projects are designed for 10 year so that they will be safer but it helps to have the standards accepted by the entire industry when they are explaining the system.
