**CALL TO ORDER:**

**Mr. Harbison called the meeting to order at 9:06 a.m.**

**PLEDGE OF ALLEGIANCE:**

**APPROVAL OR CORRECTION OF THE FOLLOWING MINUTES:**

**Mr. Wilkinson moved to approve the August 26<sup>th</sup> meeting minutes, Mr. Brinkworth second, all voted in favor.**

**BIDS:**

**COMMUNICATIONS - PUBLIC:**

**Robert Armhurst** wanted to know what the board was going to do about his drainage problem.

**Mr. Harbison** explained to him that this was not the correct board and asked if he could wait until the next meeting.

**Mr. Brinkworth** stated that the last he heard about was that the line was going to be televised to see what the problem is with the line.

**There was a lengthy discussion regarding Mr. Armhurst's problem and who needs to address the issue.**

**COMMUNICATIONS - CITY OFFICIALS**

**Mrs. Garry** presented the corrected resolution for the sewer salaries to be approved by the board.

**Mr. Wilkinson moved to approve, Mr. Brinkworth second, all voted in favor.**

**SEWER ADJUSTMENTS:**

**NEW BUSINESS:**

**Item #1 - Greg Fifer re: Municipal Pretreatment Ordinance Draft**

**Mr. Sartell** explained that they went through the ordinance and up-dated to meet the IDEM and EPA requirements.

**Mr. Wilkinson** asked if the when a new ordinance is drafted if the old one is considered dead and the new one takes its place.

**Mr. Fifer** explained that Mrs. Wisman has a company that codifies it into the ordinance book and it will refer to the most recent ordinance as well as the older one.

**Mr. Brinkworth moved to recommend this to the City Council for approval, Mr. Wilkinson second, all voted in favor.**

**Mr. Harbison** asked Mr. Fifer about Mr. Armhurst's situation.

**Mr. Fifer** stated that he has passed this onto Mr. Gibson but he does not know where he got the idea that the city is going to buy his house. He asked if the entire length had been televised.

**Mr. Marinaro** explained that they can't run a camera through the line because the floor is too uneven. He stated that the only way to get a look at the line was to send a man into the line and they would need to hire someone to do that.

**There was a lengthy discussion regarding the line and how to determine where the damage is and how to repair it.**

**OLD BUSINESS:**

**Item #1 - Clark Dietz Update**

**Mr. Christmas** informed the board that the SRF has completed the environmental impact study and that they will be able to open them up for bid on October 15. He informed them that he has contacted another Municipality for them to go out and observe the pipelining and he just needs to know who is going to attend and when they are available.

**There was a lengthy discussion regarding travel time and what would be the best date for everyone.**

**Mr. Marinaro** presented the variance request for Park Community Federal Credit Union. He stated that they received the BAN Waiver from IDEM and this is the next step in the process.

**Mr. Harbison signed the variance.**

**Mr. Marinaro** stated that they should have a resolution on Beechwood by the next meeting.

**Mr. Brinkworth** asked what they found out about the Vincennes collapse.

**Mr. Marinaro** stated that the cause was storm water related. He stated that there were three lines that come together that had no junction box or catch basin and they had a road sign laid over them with some concrete over the top and that collapsed when they were digging and there was another pipe that had a hole that they just laid a concrete pipe over the top of it.

She stated that this causes issues with the individuals and the title companies so they can try to work with the individuals by getting confirmation that it has been paid and sending out letters saying that it is in the process of being released.
