

**THE SEWER BOARD MEETING OF THE CIVIL CITY OF NEW ALBANY, INDIANA, WAS HELD IN THE THIRD FLOOR ASSEMBLY ROOM OF THE CITY-COUNTY BUILDING ON THURSDAY, NOVEMBER 12, 2015 AT 9:15 A.M.**

**PRESENT:** Mayor Gahan, president, Ed Wilkinson, member and Nathan Grimes, member.

**ALSO PRESENT:** Rob Sartell, April Dickey, Linda Moeller, Shane Gibson, Larry Summers and Vicki Glotzbach

**CALL TO ORDER:**

**Mayor Gahan called the meeting to order at 9:15 a.m.**

**PLEDGE OF ALLEGIANCE:**

**APPROVAL OR CORRECTION OF THE FOLLOWING MINUTES:**

**Mr. Wilkinson moved to approve the October 22, 2015 Regular Meeting Minutes, Mayor Gahan second, all voted in favor with the exception of Mr. Grimes who abstained.**

**BIDS:**

Manhole Rehabilitation

**Mr. Sartell** presented the following bids for manhole relining and recommended going with the low bid from Culy Contracting because they add structure to the manholes:

**Mr. Grimes** asked if this is for 56 manholes.

**Mr. Sartell** replied yes.

**Mr. Wilkinson moved to approve the Culy bid in the amount of \$90,000.00, Mr. Grimes second, all voted in favor.**

**SEWER ADJUSTMENTS:**

**Mrs. Dickey** presented an adjustment request for Mike DiMartino in the amount of \$1,238.36 for a leak that occurred at the main line. She explained that the water drained into the yard and the leak was repaired by Mr. DiMartino. Supporting documents are attached.

**Mr. Wilkinson moved to approve, Mr. Grimes second, all voted in favor.**

**Mrs. Dickey** presented an adjustment request for John Spicer in the amount of \$3,980.29 for a leak that occurred at an underground elbow connection. She explained that the water drained underground and the leak was repaired by Stemler Plumbing. Supporting documents are attached.

**Mr. Wilkinson moved to approve, Mr. Grimes second, all voted in favor.**

**Mrs. Dickey** presented an adjustment request for Colonial Club Homeowners in the amount of \$14,591.75 for a leak that occurred in the pipes underneath building 1. She explained that the water drained into the bathroom floors and drainage ditches and the leak was repaired by Greenwell Plumbing. Supporting documents are attached.

**Mr. Wilkinson** asked if this one actually happened in 2014.

**Mrs. Dickey** replied yes but there were some in 2015 as well.

**Mr. Wilkinson** stated that he would like to set this one aside to review it further. He also stated that he would like to consult with Mr. Gibson about a policy on the length of time of our responsibility. He added that we have four others tabled that date back three or four years.

**Mr. Gibson** stated that we just need to develop a policy.

**Mr. Grimes** asked if there is a statute of limitations on anything like this.

**Mr. Gibson** replied no and stated that he would put together a draft of a policy for the board to review.

**FINANCIAL REPORT:**

**Mr. Wilkinson** stated that there are two items that stand out. He explained that we had three payrolls this last month so it is \$50,000.00 higher than normal and we had two electric bills because Duke didn't get the bill in last month. He said that there are five projects going right now and we are under budget as far as spending and operations go.

**NEW BUSINESS:**

**Mayor Gahan** stated that he wanted to take a moment to let the board know how much he appreciates their service and feels that they have done a superb job. He added that the utility is healthy financially and the operation is incredibly important to the overall success of the city. He said that under this board's leadership along with the controller, the attorney and the city engineer, we have come a long way and done some really great things. He again thanked everyone for their service.

**OLD BUSINESS:**

**1. Rob Sartell re: Application for sewer credits for AHEPA Affordable Housing Management**

**Mr. Sartell** stated that he has the application for sewer credits for AHEPA in the amount 20,500. He also stated that Mr. Christmas is requesting more credits from EPA.

**Mr. Gibson** stated that the request has been submitted.

**Mr. Summers** stated that he spoke with Mr. Christmas last week and told him that we need to really start pushing for credits.

**Mr. Gibson** asked how many credits that would leave us.

**Mr. Sartell** replied around 80,000.

**Mr. Wilkinson** stated that we will have 250,000 credits from Georgetown.

**Mr. Sartell** stated that those have not been awarded yet.

**Mr. Wilkinson** stated that we have them in the bank.

**Mr. Summers** stated that his only concern was that leaves us with only 80,000 credits and whether that would be enough to hold us over until we hear from EPA.

**Mayor Gahan** asked when we could expect to hear from EPA.

**Mr. Gibson** replied that he has no idea and would need to speak with Mr. Christmas. He added that we could follow up on a more regular basis.

**Mr. Sartell** stated that Mr. Christmas said that EPA told him to get back with them when we get close.

**Mr. Wilkinson** explained that the various construction projects that we have in place is going to reduce our amount of SSOs so that would remove the need for them to pressure us and then we could request relief from EPA.

**Mayor Gahan** stated that we have some other things going with affordable housing so he doesn't want to move forward if it is going to be two years before we know what credits are. He then asked what the timeline is on this.

**Mr. Sartell** stated that this would be the third time it has been tabled.

**Mayor Gahan** asked if it has already gone through planning and zoning.

**Mr. Sartell** stated that he doesn't think that it can until sewer credits are approved.

**Mr. Wilkinson moved to approve the sewer credits, Mr. Grimes second, all voted in favor.**
