**Mr. Wilkinson** reported that the billing for last month was \$1,148,000.00 which is low but that is usually how December/January looks. He added that everything else stayed the same.

#### 1. Clark Dietz Update

**Mary Austin** reported that IDEM has requested that the runoff from the splash pad go into the sanitary sewer instead of draining to the ground so they are working on clarification from them. She added that the new regulations on the water service side are very strict so she doubts that is something they will be able to get an exemption from. She stated that the next step will be to look at the cost of taking it to the sanitary sewer or possibly installing a recirculatory system.

**Mr. Wilkinson** asked if they came up with any loading that they thought was coming from that wash when talking about flush hydrants.

**Ms. Austin** stated that as far as flushing the hydrants on the water side, they are required to dechlorinate it. She added that it is different on the private side but on the public side, even perfectly treated water has to be dechlorinated.

**Mr. Wilkinson** stated that they want to see the timing so if there are any changes it will show up in the volume. He added that if they dump everything to the sewer line this won't change because it has been done that way for a hundred years.

**Ms. Austin** explained that right now the water is going into the ditches so they want to get the chlorinated water into the sanitary sewer system. She stated that she should have a budgetary predesign number by next week to pipe everything to the sanitary sewer and install a circulatory system.

Mayor Gahan asked if she could give him the state statute code that changed.

Ms. Austin stated that she doesn't have it right now but she will get it to him
