# THE SEWER BOARD MEETING OF THE CIVIL CITY OF NEW ALBANY, INDIANA, WAS HELD IN ROOM 100 AT NEW ALBANY CITY HALL ON THURSDAY, MARCH 23, 2023 AT 9:15 A.M.

PRESENT: Ed Wilkinson, member, Nathan Grimes, member, and Mayor Gahan, president

## CALL TO ORDER:

Mayor Gahan called the meeting to order at 9:15 a.m.

### **PLEDGE OF ALLEGIANCE:**

### **APPROVAL OR CORRECTION OF THE FOLLOWING MINUTES:**

Mr. Grimes moved to approve the March 9, 2023 Regular Meeting Minutes, Mr. Wilkinson second, all voted in favor.

#### **NEW BUSINESS:**

### **COMMUNICATIONS - PUBLIC:**

Mr. Darrell Neeley stated that on March 16 Councilman Josh Turner sponsored a resolution to make all public meetings streamed on the transparency portal. He added that it was shot down with only three votes in support for various reasons such as cost, extra work to turn on the already installed system, keeping a library of sensitive materials, legality and upcoming legislation. He stated that he is here today to respectfully request that this board stream their meetings because having transparency in government is a fundamental right of democracy and citizens should be able to view every public meeting, not just the council meeting. He added that not all citizens can attend public meetings and may not be able to watch when the meeting is live, therefore the city should provide a video bank to allow citizens to watch meetings at their convenience. He went on to say that our Founding Father's stressed the importance of each American being a responsible informed citizen, and by not streaming these meetings we are hindering citizens from attending meetings and being informed. He stated that communication is the key to success and for our city to be successful we must have constant communications between the citizens and representatives because the more citizens that are involved the better city government will be. He added that millions were spent to have an updated state of the art City Hall and when the plans were voted on Mayor Gahan stated that "this plan brings new economic development to Main Street, it adds more technology and efficiency to city government". He stated that the capacities are already install and city council has been streaming for a year, but very seldom can a citizen go back and view a meeting if they missed it. He added that it should not be any extra cost to stream these meetings as the citizens are already paying IT \$82,000.00 a year so one would think he can handle the extra load of flipping the switch and downloading the stream, plus it is covered in his job description. He added that the stream can be downloaded and stored on YouTube for free, and added that these meetings are important with some already attending and streaming. He stated that legality isn't a problem because sensitive material should not be discussed at a public meeting, so shame on them if they are doing so and it isn't the citizen's fault. He and he urged them to not wait for the state legislation to tell them what to do as they were voted in or appointed in to be leaders, not followers. He added that the citizens are paying for this building and deserve to see what is going on inside of it.

**Mr. Andrew Nicholson** stated that city hall currently streams city council meetings so the technology is available. He explained that this board is 1 of 18 boards that sit in this room that have the same capabilities. He asked as a citizen, who also livestreams any meeting he attends. He stated that he gets an average of 75 views before he hits end so that is 75 people that can't attend these meetings. He added that he is going to encourage the same from all 18 meetings that

Sewer Board March 23, 2023 happen in this room. He stated that he understands that it won't be the same capabilities at other meeting but they have no reason for the one that is happening right now. He stated that he doesn't see why the City of New Albany doesn't have a YouTube channel as it would make them easily uploaded and archived, so if anyone has any questions about what happened at a previous meeting they can go back and review the video. He added that to not want to do this is a red flag for all citizens of New Albany on how involved they want them to be in government. He went on to say that not everyone can attend these morning meetings and if he didn't have the privilege of working from home, he wouldn't be able to, but he would want to attend. He encouraged them to look in to at least turning on the livestream immediately.

**Mayor Gahan** stated that he appreciates them coming to the meeting today because they do take all of this seriously. He explained that they recently put \$750,000.00 in body cameras for NAPD so they are concerned about it, but in the meantime, today we have minutes on every meeting and it is the first order of business at every meeting to go over the minutes of the previous meeting. He added that all the actions are documented and the clerk does a super job of capturing this. He stated that the minutes are available with an action by any board documented so it isn't like they doing anything outside of a public meeting. He added that not everyone can be in attendance and he hears their point be he wants them to know that they are working on it.

**Mr.** Nichols stated that it is nothing personal but the clerk is only required to transcribe and not record word-for-word.
