Mr. Thompson called the meeting to order at 10:03 a.m.

NEW BUSINESS:

1. Derek Misch, Christiani re: Request Lane closure on E. Market Street between Pearl Street and Bank Street

Mr. Misch explained that they had to close the westbound lane of E. Market Street this morning between Pearl and Bank streets to perform a utility repair investigation on a small spot that opened up where they installed the water main. He added that he checked in with them this morning and they haven't found anything yet. He stated that they will get it backfilled and restored as quickly as they can.

Mr. Thompson stated that September 5&6 was reflected on the map.

Mr. Misch stated that he added September 6 just in case anything happened that took more than a day to fix but they haven't seen anything that will require a huge fix. He added that restoration will depend on concrete availability so he will double check on that as well.

Mr. Thompson stated that he was contacted about the sinkhole appearing and given its proximately to where Cristiani installed the water main he asked them to check it out first.

Mr. Brewer asked how they typically test the line to make sure it isn't leaking.

Mr. Misch explained that if it is an old utility like that may be falling apart, they will cap it and secure it as best they can to repair it.

Mr. Thompson stated that the main thing is that they haven't found a void under there so it isn't a utility that is causing it. He added that Mr. Misch dropped letters off at all of the businesses to let them know about the work.

Mr. Misch stated that he spoke to or dropped letters off to all the businesses within that block of Market Street last week. He added that he emailed an additional individual that is closer to Main and Bank as she likes to share that information with others.

Mr. Brewer moved to approve the lane closure for today and possibly tomorrow, Mrs. Cotner-Bailey second, motion carries.

COMMUNICATIONS – PUBLIC:

Ms. Melissa Zink requested a dumpster permit for 1318 E. Elm Street. She stated that they are in the final phases and there is a little more trash than what they can haul in a pickup truck.

Mrs. Cotner-Bailey asked what dumpster company she is using.

Ms. Zink replied Gotta Go Dumpster. She added that they are having trouble with a backlog of dumpster requests so she is hopeful that she will be able to get one in by Friday and it will likely only be on the street for 3-4 days.

Mr. Thompson stated that she can let the clerk's office know when the dumpster is placed so they know to start the clock on the permit.

Mrs. Cotner-Bailey moved to approve the dumpster request for one week pending notification to the city clerk's office when the drop-off date is confirmed, Mr. Brewer second, motion carried.

4. Larry Summers re: Main Street Project Update

Mr. Summers reported that this week they will be cleaning the building faces and removing any concrete spatter from benches. He stated that they will be installing tree lights and electrical receptacles on the north side, and stripers will finish up the handicap spots and side street center lines.

5. Larry Summers re: 2023 Paving Project Update

Mr. Summers reported that asphalt will be going down on Old Vincennes and West 6th Street, milling/patching/paving on East Market Street and Corydon Pike, and installing a concrete swale at the intersection of East Market and Beharrell. He added that they are still working on concrete work for Oakwood Court. He reported that Libs Paving, as part of closing out last years contract, will be working on Greendale Drive, Lawn Court and Dale Court. He added that they will start with concrete work, similar to how they did the Brentwood Heights area last year.

Mrs. Cotner-Bailey asked if notification is going out to the residences impacted in that area.

Mr. Summers replied yes.
