4. Jessica Campbell re: Change Order No. 1 for 2022 CCMG New Albany Paving and Repairs Project

She explains that everything needs to be wrapped up and sent to them by December 1 and along with that comes Change Order #1 that is a large deduct for adjustment of all the final quantity work.

5. Jessica Campbell re: Retainage release for the 2022 Annual Paving and Repairs Project
