Mr. Thompson called the meeting to order at 10:04 a.m.

COMMUNICATIONS – PUBLIC:

Mr. Qwyntrell Christiason, Valiant Construction, presented a drawing for the board to review. He requested a partial lane closure at 1943 Ekin Avenue as well as the sidewalk for approximately four hours to remove a tree at the National Cemetery.

Mrs. Cotner-Bailey asked when they want to do the work.

Mr. Christiason stated that they would like to do the work from 11/29-12/01

Mr. Thompson asked what time they want to start.

Mr. Christiason stated that they can adjust their time to whatever fits the city's needs.

Mr. Thompson asked if they were just going to be in the parking lane.

Mr. Christiason stated that there is a parking lane but they will also need one driving lane for safety and to take the tree out.

COMMUNICATIONS – CITY OFFICIALS:

- 1. Vicki Glotzbach for Ada King (Tiny Elm, LLC) re: removal of handicapped parking in front of 603 East Elm Street**

Mrs. Glotzbach stated that Ms. Ada King emailed her office to request removal of the handicapped parking space in front of 603 E. Elm Street. She explained that Ms. King owns the property through her LLC, which is Tiny Elm, LLC, and a previous renter requested the handicapped parking space, but that renter no longer occupies the property.

Mrs. Cotner-Bailey moved to approve, **Mr. Brewer** second, motion carries.

2. Larry Summers re: 2023 Paving Update

Mr. Summers reported that this week MAC is going to be working on Camp Avenue from Corydon Pike to Knob Avenue and Cherry Street Hill from Adams Street to Old Vincennes Road. He added that there are some pretty gnarly areas on the centerlines of both roadways and they will be milling and patching it down the middle. He stated that concrete work is continuing on S. Audubon and potentially moving over to N. Audubon and AllTerrain will continue striping work once temperatures go back up.

Mrs. Cotner-Bailey asked if they are making sure that the crosswalk bars are being put down while they are doing the other markings.

Mr. Summers stated that everywhere that has been paved they have denoted all the areas that need striping and as they go back in, they take them off the list to make sure they get taken care of.

3. Mickey Thompson re: Dumpster permit at 322 E. 13th Street

Mr. Thompson presented a request at this address for two weeks starting today and add they will be using Integrated Crushed Aggregate for their dumpster. He added that they previously approved a dumpster at this location but they need an extension.

Mrs. Cotner-Bailey moved to approve, Mr. Brewer second, motion carries.

4. Mickey Thompson re: Clark Remc Durgee Road

Mr. Thompson for Clark Remc requested permission to bore under Durgee Road and into 606 Durgee Road. He stated that this is in the city's portion of the road and the bore pit will be in the grass area, so there is no disturbance to the road.

Mrs. Cotner-Bailey moved to approve, Mr. Brewer second, motion carries.

5. Mickey Thompson re: Closure on W. 10th Street

Mr. Thompson explained that last week Mr. Fair informed the board that they would be installing the 10th Street flood wall closure, but there was a problem with the equipment delivery and it has been pushed back one week.

Mrs. Cotner-Bailey moved to approve the new date for the closure of W. 10th Street with the dates pending equipment rental delivery, Mr. Brewer second, motion carries.
