**Mayor Gahan** called the meeting to order at 9:15 a.m.

**SEWER ADJUSTMENTS:**

**Mrs. Dickey** presented a leak adjustment request for Tate Watson in the amount of \$2,112.32 for a leak that was outside under the parking lot going from the main line to the building. She explained that the water wet into the parking lot, the leak was repaired by Greenwell Plumping, and consumption is back to normal. She added that there was a delay in getting paperwork because the landlord had to step in. Support documents are attached.

She added that for the bill to be that high the water had to go through the meter so she believes they just didn't understand the mechanicals of how that would work and reported it by the meter.
